**Under the Scrapie Eradication Program rules (November 19, 2001) sheep and goats must have one of the following forms of identification to be moved interstate for sale or exhibition or for change of ownership or exhibition within California and Nevada**

- Scrapie Identification Eartags
- Registry Tattoo or electronic ID if accompanied by registration papers, which include the tattoo or EID number. (Limited to certain breeds of goats)
- Approved Premises ID Tattoos
- Voluntary Scrapie Certification Flock Identification Eartags, Tattoos or Electronic ID
